

DONATION OF PUBLICLY TRADED SECURITIES TO SECHELT HOSPITAL FOUNDATION

Thank you for your interest in donating securities to Sechelt Hospital Foundation. A gift of securities is a cost and tax effective opportunity to transform an asset into immediate and significant support for our community hospital. By donating publicly traded securities (stock, bonds, segregated funds or mutual funds), you eliminate the capital gains tax that becomes payable if you were to sell the appreciated securities on the market.

Transferring securities is very easy to do. Simply follow these directions:

- 1. Advise your Broker of your wish to make a gift of Securities to the Sechelt Hospital Foundation. With the assistance of your Broker, complete the attached form.
- 2. Your broker will deliver the form and the securities to our agent, CIBC Wood Gundy.

- Upon receipt of the transferred securities (which may take up to two days or a few weeks in the case of mutual funds) to the Foundation's brokerage account, CIBC Wood Gundy will advise us in writing of the receipt of the securities and the closing bid value.
- 4. We will issue an official receipt to you, for income tax purposes, for the market closing price on the day they are received in our CIBC Wood Gundy account. (Please note that estate gifts may have a different valuation process. Please contact your financial advisor for more information.)
- 5. It is the Foundation's policy that securities, once received by the Foundation or its broker, will be sold in accordance with the Foundation's Investment Policy.
